2 entered August 13, 2001, in connection with the application of the parties for approval
3 of the settlement set forth in the Stipulation of Settlement dated as of July 31, 2001 (the
4 "Stipulation"). Due and adequate notice having been given to the Class as required in
5 said Order, and the Court having considered all papers filed and proceedings had
6 herein and otherwise being fully informed in the premises and good cause appearing
7 therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

8 1. For purposes of this Order, the terms used herein shall have the
9 meanings set forth in the Stipulation of Settlement dated as of July 31, 2001 (the
10 "Stipulation").

11 2. This Court has jurisdiction over the subject matter of this application and
12 all matters relating thereto, including all Members of the Class who have not timely and
13 validly requested exclusion.

14 3. The Court hereby awards reimbursement of Class Notice costs to Lead
15 Plaintiffs' Claims Administrator, The Garden City Group, Inc, in the amount of
16 \$32,665.84.

17 4. The awarded expenses shall be paid to The Garden City Group, Inc.
18 immediately after the date this Order is executed subject to the terms, conditions and
19 obligations of the Stipulation.
