**ORDER CONSOLIDATING RELATED CASES FOR ALL PURPOSES**

This Court, having considered the unopposed Motion of Datastream Plaintiffs Group to Consolidate Related Cases For All Purposes, hereby makes the following Order:

1. The related actions captioned above are hereby consolidated for all purposes, including, but not limited to, discovery, pretrial proceedings and trial proceedings, pursuant to Rule 42(a) of the Federal Rules of Civil Procedure.

2. This action shall be captioned "In re Datastream Systems, Inc. Litigation," and the files of this action shall be maintained in one file under Master File No.: 6:99-0088-13. Any other actions now pending or hereafter filed in this district which arise out of the same facts as alleged in these related cases shall be consolidated for all purposes if, as, and when they are

drawn to the Court's attention. A party shall notify the Court of any other action which is pending or filed outside of this district which may be related to the subject matter of these consolidated actions.

3. Every pleading filed in these consolidated actions, or in any separate action included herein, shall bear the following caption:



When a pleading is intended to be applicable only to some, but not all, of the consolidated actions, then immediately after the words "This Document Relates To:" in the caption described above, there shall appear "Civil Action No. \_\_\_\_\_ (plaintiffs' name)" for each individual related action to which the pleading is intended to be applicable.

5. The consolidated complaint shall be the operative complaint and shall supersede all complaints filed in any of the actions consolidated herewith. Defendants shall not be obligated to respond to any of the complaints in the consolidated actions other than the consolidated complaint.
