

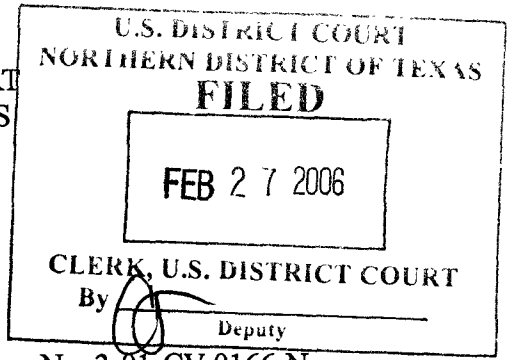




ORDERED that the case is dismissed with prejudice. Any relief not herein granted is hereby denied. This is a final judgment of dismissal.






