1           Lead Plaintiffs respectfully submit this notice of non-objection in further support of Lead  
2 Plaintiffs' Motion for Final Approval of Class Action Settlement and Plan of Allocation of  
3 Settlement Proceeds; and Plaintiffs' Co-Lead Counsel's Motion for an Award of Attorneys' Fees and  
4 Expenses.

5           Pursuant to the Court's July 7, 2010 Order Preliminarily Approving Settlement and  
6 Providing for Notice ("Order"), more than 74,000 copies of the Notice of Proposed Settlement of  
7 Class Action (the "Notice") were mailed to potential Class Members. The Notice advised Class  
8 Members of the proposed Settlement, the proposed Plan of Allocation of settlement proceeds, and  
9 the request for an award of attorneys' fees and expenses. The Notice further advised Class Members  
10 of the September 30, 2010 deadline for filing objections to the proposed Settlement, the proposed  
11 Plan of Allocation, or the request for an award of attorneys' fees and expenses.<sup>1</sup> The September 30,  
12 2010 deadline has now passed and not a single Class Member has objected to the proposed  
13 Settlement, the proposed Plan of Allocation, or the request for an award of attorneys' fees and  
14 expenses. This favorable reaction of the Members of the Class supports the reasonableness of the  
15 Settlement, the proposed Plan of Allocation, and the fee and expense request.

4 counsel in the amount of 30% of the Settlement Fund, together with expenses in the amount of  
5 \$282,906.73, plus interest on both amounts.
