1 Plaintiffs submit this Supplemental Memorandum in Support of Motion for Preliminary  
2 Approval of Settlement and a [Revised Proposed] Order Preliminarily Approving Settlement and  
3 Providing for Notice (“Notice Order”) in compliance with the Courts’ October 13, 2010 Order  
4 Setting Hearing for Preliminary Approval of Class Settlement as to the SoftBank Defendants;  
5 Vacating Status Conference (Docket No. 447) (“Order”).

6 In the Order, the Court, among other things, set a final approval hearing date of February 7,  
7 2011, at 9:00 a.m. and directed Lead Counsel to adjust dates in the Notice Order (and the attached  
8 exhibits) accordingly, with the caveat that Class Members should be given a three week time period  
9 to respond or object to Lead Counsel’s fee and expense application.<sup>1</sup> The Court also directed Lead  
10 Counsel to specifically nominate a claims administrator. The Notice Order appoints Gilardi & Co.  
11 LLC as claims administrator at ¶4.
