**STIPULATION FOR THE ENTRY OF AN ORDER
OF VOLUNTARY DISMISSAL OF JERRY L. MOSINGO**

WHEREAS, plaintiff K.J. Egleston and the class he seeks to represent as defined in the Consolidated Class Action Complaint (collectively, Mr. Egleston and the class are referred to herein as "Plaintiff"), named as a defendant in this action, among others, Jerry L. Mosingo;

WHEREAS, Plaintiff, by his undersigned counsel, has agreed to voluntarily dismiss, without prejudice, Mr. Mosingo from the Consolidated Class Action Complaint;

WHEREAS, Plaintiff's agreement to such voluntary dismissal without prejudice is made expressly subject to Mr. Mosingo's agreement to enter into a Tolling Agreement, whereby the running of any applicable limitations period with respect to claims against Mr. Mosingo arising out of the Consolidated Class Action Complaint is tolled pursuant to the terms of said Agreement; and

WHEREAS, Mr. Mosingo has entered into such a Tolling Agreement as of the time of this Stipulated Order;

THE PARTIES HEREBY STIPULATE AND AGREE to the entry of an order dismissing Mr. Mosingo as a defendant from this action without prejudice, with all parties to bear their own costs, in substantially the same form as the order submitted concurrently herewith.
