1 This Court, having considered the motion by Movant Justin Shenkarow
2 (hereinafter "Shenkarow") for appointment as lead plaintiff pursuant to Section 21D
3 of the Securities Exchange Act of 1934 and approval of Shenkarow's choice of
4 counsel, for good cause shown, hereby orders as follows:

5 IT IS HEREBY ORDERED THAT:

6 1. The matter shall be identified as: *In re Broadcom Corporation*.
7 *Securities Litigation*, and the files of this action shall be maintained under File No.
8 CV06-5036 R (CWx). Any other actions now pending or hereafter filed in this
9 District which arise out of the same facts and claims as alleged in these related
10 actions shall be consolidated for all purposes if, as and when the Court is apprised of
11 them. The parties shall notify the Court of any other action which is pending or filed
12 outside of this District which may be related to the subject matter of this action if and
13 when they become aware of such actions.

14 2. Every pleading filed in this action, or in any separate action included
15 herein, shall bear the following caption:

24 3. Pursuant to §21D(a)(3)(B) of the Securities Exchange Act of 1934, 15
25 U.S.C. §78u-4(a)(3)(B), Shenkarow is appointed Lead Plaintiff for the Class.

26 4. Shenkarow's selection of counsel is approved. Pursuant to
27 §21D(a)(3)(B)(V), the law firm of Stull, Stull & Brody is appointed Lead Counsel
28 for the Class.

1 A. Lead Counsel is vested by the Court with the following
2 responsibilities and duties:

- 3 i. To coordinate the preparation and filing of a Consolidated
4 Amended Complaint, and any subsequent pleadings;
5 ii. To coordinate the briefing and argument of all motions;
6 iii. To coordinate and conduct all discovery, pre-trial and trial
7 proceedings for plaintiffs;
8 iv. To call meetings of plaintiffs' counsel as they deem
9 appropriate or necessary from time to time;
10 v. To initiate and conduct all settlement negotiations for
11 plaintiffs with counsel for defendants;
12 vi. To provide general coordination of activities of counsel on
13 their side and to delegate work responsibilities to selected
14 counsel as may be required; and
15 vii. To perform such other duties as may be expressly
16 authorized by further order of the Court.

17 B. Lead Counsel shall make all work assignments in such a manner
18 as to conduct the orderly and efficient prosecution of this litigation and to avoid
19 duplicative or unproductive effort.
