**ORDER CONSOLIDATING J&R MARKETING AND ZIELEZIENSKI CASES,
GRANTING MOTION FOR APPOINTMENT OF LEAD PLAINTIFFS
AND FOR APPROVAL OF LEAD PLAINTIFFS'
SELECTION OF LEAD COUNSEL AND LIAISON COUNSEL**

On February 24, 2006, Plaintiffs filed a motion to consolidate actions, for appointment of lead plaintiffs, and for approval of lead plaintiffs' selection of lead counsel and liaison counsel. (Dkt. 19).

On March 8, the Court consolidated this case with Case No. 06-10727, and closed Case No. 06-10727 for administrative purposes. (Dkt. 20).

On April 3, 2006, the case of *Zielezienski v. General Motors Corp.* was transferred from the Southern District of Florida, docketed in this court as Case No. 06-11784, and assigned to the Hon. Nancy G. Edmunds. The *Zielezienski* case arises out of the same course of conduct which gave rise to Case No. 06-10201 and Case No. 10727.

On May 11, 2006, Plaintiff's counsel in *Zielezienski* filed a joinder in the motion for appointment of lead plaintiffs, and for approval of lead plaintiffs' selection of lead counsel and liaison counsel (Dkt. 28).

The Court has considered Plaintiffs' motion and the brief and affidavit filed in support of Plaintiffs' motion; and, being fully advised in the premises, the Court concludes that Plaintiffs' motion should be granted.

NOW, THEREFORE, IT IS HEREBY ORDERED AND ADJUDGED:

A. Case No. 06-11784 is consolidated with Case No. 06-10201; Case No. 06-11784 is closed for administrative purposes; and all subsequent pleadings shall be entered under the lower case number of 06-10201;

B. The Court appoints Milton Brafman and Michael A. Ramsey as lead plaintiffs;

C. The Court approves Lead Plaintiffs' selection of Lead Counsel and Liaison Counsel; and appoints:

1. The Weiser Law Firm, P.C. and Jacob A. Goldberg, LLC, as Co-Lead Counsel for the class; and
2. Stephen F. Wasinger PLC as Liaison Counsel for the class.
