1 This matter came (the "Litigation ") before the Court for hearing on September
2 29, 2008, pursuant to this Court's Order Preliminarily Approving Settlement and
3 Providing for Notice (the "Preliminary Approval Order), to consider the (1) the
4 application of Lead Plaintiff's counsel for an award of attorneys' fees and
5 reimbursement of litigation expenses incurred in the prosecution of the Litigation (the
6 "Fee Request); and (2) Lead Plaintiff's application for reimbursement of their time
7 and expenses expended in prosecution of the Litigation. The Court having considered
8 all papers filed and proceedings held herein and otherwise being fully informed in the
9 premises and good cause appearing therefore,


10 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that:

11 1. The Court finds and concludes that the Fee Request requested by Lead
12 Plaintiff's counsel of 25% of the Settlement Fund, is under the circumstances, fair and
13 reasonable, and, therefore, the Court awards Lead Plaintiff's counsel \$2,500,000, plus
14 interest hereafter from until paid based on the same rate of interest earned by the
15 Settlement Fund, to be paid from the Settlement Fund as provided in the Stipulation.

16 2. The Court finds and concludes that the request by Lead Plaintiff's
17 counsel for expenses reasonably and necessarily incurred in the prosecution of the
18 Litigation is, under the circumstances, fair and reasonable, and the Court allows Lead
19 Plaintiff's counsel's request for such expenses in the amount of \$45,163.98, plus
20 interest hereafter from until paid based on the same rate of interest earned by the
21 Settlement Fund, to be paid from the Settlement Fund as provided in the Stipulation.

22 3. The Court finds and concludes that the requested reimbursement for time,
23 efforts, and expenses is reasonable and awards Lead Plaintiff Sasco Investments, LP
24 \$12,500 to be paid from the settlement Fund as provided in the Stipulation.
