

1 Co-Lead Plaintiff T. Paul Thomas files this unopposed Motion to Withdraw as one of the
2 Lead Plaintiffs in the above-entitled action. In support, Thomas states as follows:

3 1. On March 20, 2007, T. Paul Thomas and Rosenbaum Capital, LLC jointly
4 moved, as the Thomas Group, to be appointed Lead Plaintiffs in the class action against Secure
5 Computing Corporation.

6 2. On May 3, 2007, the Court named the Thomas Group as Lead Plaintiff and the
7 law firm of Federman & Sherwood as Lead Counsel.

8 3. Since the date of the Court's order naming the Thomas Group as Lead Plaintiff,
9 Plaintiff Thomas has requested that counsel seek approval to have him withdraw as one of the
10 members of the Thomas Group.

11 4. Plaintiff Rosenbaum Capital, LLC will continue to act as Lead Plaintiff in this
12 action. Rosenbaum Capital is an institutional investor that purchased Secure Computing Corp.
13 common stock during the Class Period: (1) at prices alleged to have been artificially inflated by
14 the false and misleading and omitted statements issued by Defendants; and (2) were damaged by
15 the alleged fraud. Thus, its claims meet the typicality requirement.

16 5. The Thomas Group's motion for Lead Plaintiff was unopposed, and no other
17 purported class member sought to be named as Lead Plaintiff, nor did any purported class
18 member oppose the Thomas Group's Motion. Therefore, there is no harm in allowing Plaintiff
19 Thomas to withdraw as one of the Lead Plaintiffs. Further, allowing Plaintiff Thomas to
20 withdraw will not cause any delay or prejudice in the prosecution of this action, since Plaintiff
21 Rosenbaum Capital will continue to serve as Lead Plaintiff.

22 6. Counsel for Defendants do not oppose the withdrawal of Thomas as one of the
23 Lead Plaintiffs.
