

1 **WHEREAS**, in the Stipulation and Order Extending Time to Respond to and Setting
2 Briefing Schedule for Motions to Dismiss, the parties agreed, and this Court ordered, that
3 plaintiffs file an amended complaint no later than 45 days following the issuance of an order by
4 this Court appointing Lead Plaintiff and Lead Counsel; defendants file any response within 45
5 days of service of the amended complaint; plaintiffs file an opposition within 45 days after
6 service of a motion to dismiss; and defendants file a reply within 30 days of the opposition;

7
8 **WHEREAS**, the plaintiffs intend to file an amended complaint no later than 45 days
9 following the issuance of an order by this Court appointing Lead Plaintiff and Lead Counsel;

10 **WHEREAS**, the hearing regarding Lead Plaintiff and Lead Counsel is currently set for
11 April 27, 2007, at 10 a.m., the same time the initial Case Management Conference is currently
12 scheduled;

13
14 **WHEREAS**, the parties in this action have met and conferred and agree that it is in
15 their mutual interest to continue the Case Management Conference until after the Court has
16 ruled on a motion to dismiss the amended complaint, which is due within 45 days of the service
17 of the amended complaint; or, if no motion to dismiss is filed, within 30 days of defendants'
18 answer to the complaint;

19 **WHEREAS**, the proposed continuance will not prejudice any party and will not cause
20 undue delay;

21
22 **IT IS THEREFORE STIPULATED THAT:**

23 The Case Management Conference shall be continued until either:

- 24 (1) At least 30 days after the Court's ruling on a motion to dismiss; or
25 (2) At least 30 days after defendants' answer to the complaint is filed, whichever comes
26 first, and depending on the schedule of the Court.
