1 Having considered Movant T. Paul Thomas and Plaintiff Rosenbaum Capital LLC's
2 ("Thomas Group") Motion and Memorandum of Points and Authorities in Support of Motion;
3 For Appointment of Lead Plaintiff; and For Approval of their Choice of Counsel as Lead
4 Counsel for the Class,

5 IT IS HEREBY ORDERED THAT:

6 1. Pursuant to Section 21D(a)(3)(B) of the Securities Exchange Act of 1934 (the
7 "Exchange Act"), as amended by the Private Securities Litigation Reform Act of 1995,
8 15 U.S.C. §78u-4(a)(3)(B), class member Thomas Group is appointed to serve as Lead Plaintiff
9 for the Class of purchasers of Secure Computing Corporation securities from May 4, 2006,
10 through July 11, 2006, inclusive (the "Class Period").

11 2. The law firm of Federman & Sherwood is approved as Lead Counsel. Lead
12 Counsel shall provide general supervision of the activities of Plaintiff's counsel and shall have
13 the following responsibilities and duties to perform or delegate as appropriate:

- 14 a. To brief and argue motions;
- 15 b. to initiate and conduct discovery, including, without limitation,
16 coordination of discovery with Defendants' counsel and the preparation
17 of written interrogatories, requests for admissions, and requests for
production of documents;
- 18 c. to direct and coordinate the examination of witnesses in depositions;
- 19 d. to act as spokesperson at pretrial conferences;
- 20 e. to call and chair meetings of Plaintiff's counsel as appropriate or
21 necessary from time to time;
- 22 f. to initiate and conduct any settlement negotiations with counsel for
23 Defendants;
- 24 g. to provide general coordination of the activities of Plaintiff's counsel and
25 to delegate work responsibilities to selected counsel as may be required
26 in such a manner as to lead to the orderly and efficient prosecution of
this litigation and to avoid duplication or unproductive effort;
- 27 h. to consult with and employ experts;

- i. to receive and review periodic time reports of all attorneys on behalf of Plaintiffs and to determine if the time is being spent appropriately and for the benefit of Plaintiffs; and
