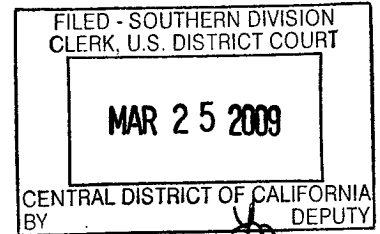

5 Proc. 58(a):


