Now pending before the Court is the motion of Loren Swanson and Art Landesman to consolidate all related actions, to be appointed Lead Plaintiffs, and to approve proposed Lead Plaintiffs' choice of counsel. No opposition has been filed to the motions. After carefully considering the moving papers, the Court rules as follows:

1. The motion for appointment as lead plaintiff is GRANTED.
2. The motion to consolidate is GRANTED. Case No. 08-cv-00683 CRB shall be consolidated into Case No. 08-cv-00271 CRB, the first case filed, and closed. All subsequent papers, pleadings, and motions shall be filed under the case number 08-cv-00271 CRB, and the consolidated action shall be re-captioned as "In re ShoreTel, Inc. Securities Litigation. Furthermore, all consolidated matters are transferred to Judge Charles R. Breyer, who is the presiding judge in the first-filed action.

1 3. Class Members, Loren Swanson and Art Landesman are appointed to serve as Lead
2 Plaintiffs in the above-captioned consolidated action pursuant to 15 U.S.C. § 77z-1(a)(3)
3 (2007).

4 4. The law firm Kahn Gauthier Swick, LLP is appointed Lead Counsel, and Hagens
5 Berman Sobol Shapiro LLP is appointed Liaison Counsel for Plaintiffs in the consolidated
6 action. Lead Counsel shall be responsible for coordination of all activities and appearances
7 on behalf of Plaintiffs and for the dissemination of notices and orders of this Court.

8 5. Defendants' counsel may rely upon all agreements made with Lead Counsel, or other
9 duly authorized representatives of Plaintiffs, and such agreements shall be binding on
10 Plaintiffs.

11 6. This Order shall apply to this action, all actions consolidated herein and to each case
12 that relates to the same subject matter that is subsequently filed in this Court or is transferred
13 to this Court and is consolidated with this consolidated action.

14 7. The Court requests the assistance of counsel in calling to the attention of the Clerk of
15 this Court the filing or transfer of any case that might properly be consolidated as part of this
16 consolidated action. Once aware of such action, the Clerk of the Court shall file a copy of
17 this Order in the new/transferred action.

18 8. Each new case that arises out of the subject matter of this consolidated action which is
19 filed in this Court or transferred to this Court, shall be consolidated with this consolidated
20 action and this Order shall apply to that case, unless a party objects to consolidation, or any
21 provision of this Order, within ten (10) days after the date upon which a copy of this Order is
22 served on counsel for such party, by filing an application for relief and this Court deems it
23 appropriate to grant such application. Nothing in the foregoing shall be construed as a
24 waiver of the Defendants' right to object to consolidation of any subsequently filed case.
