1 Upon consideration of the motions and supporting papers filed by the movants for lead plaintiff
2 in the above-captioned actions and for good cause shown, and no competing motions having been filed,

3 **IT IS HEREBY ORDERED THAT:**

5 1. The Motion Of The Van Dyke Group For Appointment As Lead Plaintiff And Approval Of
6 Selection Of Counsel is **GRANTED**;

7 2. Plaintiff Lindell Van Dyke and class member Sandra Olsen are hereby **APPOINTED** to
8 serve as Lead Plaintiff in this action, pursuant to Section 21D(a)(3)(B) of the Securities Exchange Act of
9 1934 ("Exchange Act"), 15 U.S.C. § 78u-4(a)(3)(B), as amended by the Private Securities Litigation
10 Reform Act of 1995. The Van Dyke Group has complied with the requirements of the PSLRA, has the
11 largest financial interest in this action and meets the relevant requirements of Fed. R. Civ. P. 23. *See* 15
12 U.S.C. § 78u-4(a)(3)(B)(iii). The Van Dyke Group is therefore appointed to serve as Lead Plaintiff in
13 this action.

14
15 3. The law firm of Girard Gibbs LLP is hereby **APPOINTED** to serve as Lead Counsel for
16 the Class, pursuant to Section 21D(a)(3)(B) of the Exchange Act, 15 U.S.C. § 78u-4(a)(3)(B), as
17 amended by the Private Securities Litigation Reform Act of 1995, in the above-captioned action. The
18 presumptive Lead Plaintiff selects counsel to represent the Class under the PSLRA, subject to Court
19 approval. 15 U.S.C. § 78u-4(a)(3)(B)(v). As Girard Gibbs is experienced in the prosecution of
20 securities class actions and will adequately represent the interests of Class members, the Court approves
21 the Van Dyke Group's selection of counsel to represent the Class.

22 **SO ORDERED.** The hearing date of August 22, 2008 is **HEREBY VACATED**.
