Rudman Defined Benefit Plan (“Movants” or “Rudman Investors”) will move this Court, on December 19, 2008 at 10:00 am, or at such time as may be designated by the Court, for an Order (attached hereto as Exhibit A): (i) consolidating the Actions; (ii) appointing the Movants as Lead Plaintiffs; (iii) approving the Movants’ selection of the law firm of Kirby McInerney LLP to serve as Lead Counsel; (iv) approving Lead Plaintiffs’ selection of the law firm of Bouchard Margules & Friedlander, P.A. to serve as Local Counsel; and (v) granting such other and further relief as the Court may deem just and proper.

This motion is brought pursuant to Fed. R. Civ. P. 42(a), the Securities Act of 1933 and the Securities Exchange Act of 1934 as amended by the Private Securities Litigation Reform Act of 1995 (“PSLRA”), and is made on the ground that good cause exists for the granting of the Order sought.

Consolidation is warranted because the above-captioned actions all involve the same defendants, claims and proposed plaintiff class. Movants are entitled to appointment pursuant to the PSLRA because Movants are believed to have the largest financial interest in the relief sought by

the proposed class, of all timely-moving and otherwise-adequate class members. In support of this Motion, Movants submit herewith a Memorandum of Law and Declaration of Ira M. Press.
