1 For the reasons set forth in the Court's Orders dated January 28, 2010 and  
2 February 22, 2010, in accordance with Federal Rule of Civil Procedure 58, and for  
3 good cause appearing,

4 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

5 1. Plaintiff William Jurkowitz's purported class action complaint against  
6 Defendants Pacific Capital Bancorp, George Leis, David Porter, Sandler O'Neill &  
7 Partners L.P., and Sandler O'Neill Asset Management LLC (Sandler O'Neill Asset  
8 Management LLC having previously been voluntarily dismissed) is hereby  
9 dismissed with prejudice in its entirety;

10 2. Plaintiff Thomas Shotke's purported class action complaint against  
11 Defendants Pacific Capital Bancorp, George Leis, David Porter, and Sandler  
12 O'Neill & Partners L.P. is hereby dismissed with prejudice in its entirety;

13 3. This consolidated action is dismissed with prejudice in its entirety  
14 with respect to all Plaintiffs, including the remaining named Plaintiffs Peter Pagano,  
15 Marjorie Pagano, Peter Alex Pagano, and Johnny Rios;

16 4. Plaintiffs shall take nothing by way of this action;

17 5. Final judgment is entered in favor of Defendants; and

18 6. Defendants are the prevailing parties and shall recover their costs to  
19 the extent allowable by law.
