3. Defendants are not required to respond to any of the complaints previously filed in the Related Actions;

4. Plaintiffs shall file any motion to be appointed Lead Plaintiff in accordance with 15 U.S.C. Section 77z-1 and 15 U.S.C. Section 78u-4;

5. Plaintiffs shall have 60 days from the appointment of a Lead Plaintiff and Lead Counsel to file a consolidated complaint;

6. Defendants shall answer or otherwise respond to the consolidated complaint no later than 60 days after the filing of the consolidated complaint;


